Timing

All times are present London time (GMT+1). For Maastricht and Madrid (GMT+2), add one hour. For Athens and Moscow (GMT+3), add two hours. For Singapore (GMT+8), add seven hours. For Tokyo (GMT+9), add eight hours. For Wellington (GMT+12), add eleven hours. For Brasília (GMT-3), subtract two hours. For Baltimore (GMT-4), subtract three hours. For Austin (GMT-7), subtract six hours.

Presentations start “cum tempore” (i.e., 5 minutes after schedule) to allow for entry and exit. Speakers have 15 minutes, discussants 5 minutes. Any remaining time is left for questions from the floor.

Role of Session Chairs and Zoom Hosts

Session Chairs take care that the schedule is kept to, that Q&A is well-organized, and that time is split evenly across presentations.

Zoom Hosts support the Session Chair by ensuring the smooth functioning of online sessions. Specifically, Zoom Hosts (i) allow presenters to share their screen, (ii) mute attendants that cause background noise, and (iii) arrange break-out sessions during the coffee breaks. Zoom hosts need to arrive in time for the handover, and should never leave early (because that ends the session). In the event that a Zoom Host unexpectedly loses connection to the session, he or she must immediately turn to the channel creator, i.e., to Iwan for Channel A and to Christian for Channel B.
